Subject: YUK TUNG (IMO 9030591)

Date: 1 February 2018

Please be advised that the Dominica-registered vessel Yuk Tung (IMO 9030591) has been suspended from the Commonwealth of Dominica registry and considered deregistered due to having been found to have conducted a ship-to-ship transfer to the United Nations sanctioned vessel Rye Song Gang 1 (IMO 7389704) in violation of international law. The vessel is prohibited from registration in another State to preserve enforcement rights under Dominica and international law.

The vessel Yuk Tung is owned by Yuk Tung Energy Inc., which has a registered address of First Floor, BCI House, Avarua, Rarotonga, Cook Islands and is beneficially owned by Tang Kok Wah of 524, Jelapang Rd., #05-317, Singapore, 670524 who is the company's sole shareholder. The vessel is operated by Yuk Tung Energy Pte. Ltd. located at 80 Raffles Place, UOB Plaza 2, #17-22, Singapore, 048624.

Yuk Tung Energy Inc. and Yuk Tung Energy Pte. Ltd. have both been assessed fines in the amount of 1.2 million each for egregious violations relating to the ship-to-ship transfer to the vessel Rye Song Gang 1.

The Dominica Maritime Registry Inc. (DMRI) maintains a strict policy towards sanction compliance and will investigate and take appropriate action against sanction violators to maintain the integrity of the Dominica fleet and to further the safety of life at sea.

Subject: Notice Regarding Seafarers onboard Yuk Tung (IMO 9030591)

Date: 1 February 2018

Please be advised that the Dominica-registered vessel Yuk Tung (IMO 9030591) has been suspended from the Commonwealth of Dominica registry due to having been found to have conducted ship-to-ship transfer to the United Nations sanctioned vessel Rye Song Gang 1 (IMO 7389704) in violation of United Nations Security Council (UNSC) Resolution 2375 (2017) and UNSC Resolution 2397 (2017).

The Dominica Maritime Registry Inc. (DMRI) is asking all Port or Coastal States in receipt of the subject vessel to detain the seafarers found serving onboard and immediately notify the registry. According to the last crew list received for the vessel, DMRI believes the following individuals to currently be onboard and subject to the requested detainment for investigative purposes.
