PURPOSE: This Circular serves to provide up-dated format of the Continuous

Synopsis Records.

APPLICABILITY: This Circular applies to Owners and Operators of all vessels of 500

gross tons (ITC) or more registered under the Dominica Maritime Registry. The amendments to the format of CSR will enter into force

on 1 January 2009.

BACKGROUND:

In May 2005, IMO adopted a new SOLAS regulation XI-1/3-1 *Company and registered owner identification number* and amendments to regulation XI-1/5 on the mandatory company and registered owner identification number, with entry into force expected to be on 1 January 2009.

Regulation 3-1 states that "every Company and registered owner shall be provided with an identification number which conforms to the IMO Unique Company and Registered Owner Identification Number Scheme adopted by the Organization." It refers to resolution MSC.160 (78) entitled "Adoption of the IMO Unique Company and Registered Owner Identification Number Scheme", adopted in 2004 as a measure to enhance maritime safety, security and environmental protection, and to facilitate the prevention of maritime fraud. Its purpose is to

assign a permanent number for identification purposes to each Company and/or Registered Owner managing ships engaged on international voyages.

Resolution MSC.198 (80) introduced the amendments to the format of CSR in order include the registered owner and the company identification numbers.

REQUIREMENTS:

IMO Unique Company and Registered Owner Identification Number

- 1.0 All of the Companies and Registered Owners managing Dominica flagged ships of 100 gross tonnage and above engaged on international voyages shall be provided with an identification number which conforms to the IMO Unique Company and Registered Owner Identification Number Scheme adopted by the IMO.
- **2.0** Detailed procedures and guidance on obtaining IMO Company and Registered Owner Number is described in circular CD-MSC 01-08 rev. 01 *Company and Registered Owner Identification Number*.

Implementation

- 3.0 The Commonwealth of Dominica is implementing the Scheme with the effect as of the 25 November 2008.
- **4.0** Companies and Registered Owners of ships which are required to be issued CSR are therefore required to notify the Commonwealth of Dominica Maritime Administration of the Numbers assigned to them without delay.
- **5.0** This policy is to ensure that ships comply with the requirements prior to the date of to the date of entry into force, i.e. 1 January 2009.
- 6.0 The Continuous Synopsis Record (CSR) (insertion of Registered Owner and Company Numbers) will have to be reissued prior to 1 January 2009.
- 7.0 In accordance with the provisions of SOLAS 1974, as amended, Regulation IX-1/3-1.5, the International Safety Management Code (ISM Code) and International Code for the Security of Ships and Port Facilities (ISPS Code) certificates, which are issued by the Commonwealth of Dominica Maritime Administration or by the Commonwealth of Dominica Recognized Organizations, shall be amended to include the IMO Company number when the affected certificate is issued or renewed on or after 1 January 2009.

- **8.0** The Applications for Continuous Synopsis Record (CDVR-2023) is attached as Annex 1 to this Marine Safety Circular.
- **9.0** The Continuous Synopsis Record Form (CDVR-3043), CSR Amendment Form (CDVR-2023a) and Index of Amendments to CSR Form (CDVR-2023b) are attached as Annexes 2, 3 & 4, respectively, to this Marine Safety Circular.
