TO: ALL SHIPOWNERS, OPERATORS, MASTERS AND OFFICERS OF MERCHANT SHIPS, AND AUTHORIZED CLASSIFICATION SOCIETIES

SUBJECT: REPORTS ALLEGING INADEQUATE MARPOL PORT RECEPTION FACILITIES

REFERENCE: MARPOL 73/78, Consolidated Edition, 2002, Annex I, II, IV and V

PURPOSE: This Circular describes the procedures for owners or operators of Commonwealth of Dominica flag vessels to report allegations of inadequate port reception facilities for oily wastes, noxious liquid substances, and/or garbage to the Flag Administration.

APPLICABILITY: Nations which are signatory to MARPOL 73/78 are obliged to provide adequate port reception facilities for oily wastes in accordance with Regulation 12 of MARPOL Annex I and for noxious liquid substances as specified in Regulation 7 of MARPOL Annex II. In addition, States which have adopted Annex IV and Annex V to MARPOL 73/78 must provide suitable port facilities for sewage reception in accordance with Regulation 10 (Annex IV) and for garbage reception in accordance with Regulation 7 (Annex V).

REQUIREMENTS:

Under current International Maritime Organization (IMO) guidelines, a report highlighting the specific deficiencies should be forwarded to the Flag Administration when the Master of a ship encounters inadequate or non-existent port reception facilities. If the Commonwealth of Dominica finds merit in the allegation, the details of the alleged contravention shall be forwarded to the IMO for communication to the Parties concerned.

The form of Report on Alleged Inadequacy of Port Reception Facilities (Form CDVR-4009), as annexed to this Circular, should be used for reporting allegations of non-existent or inadequate port reception facilities to the Office of the Deputy Maritime Administrator, Maritime Affairs, in

Fairhaven, Massachusetts, USA, address noted on the form. This reporting form has separate sections applicable to port reception facilities for waste oil, noxious liquid substances, sewage and garbage and the appropriate section(s) should be fully completed.

If the allegations appear valid, the information contained in Form CDVR-4009 will be used as the basis for developing the report(s), which will be forwarded by the Administration to the IMO.

In addition, the Annual MARPOL 73/78 Report filed by the Administration with the IMO also contains a listing of inadequate or non-existent port reception facilities reported during the past year.
