SUBJECT: International Maritime Conventions, Protocols, and

Amendments to which the Commonwealth of Dominica is a

Party.

REFERENCE: (a) The Dominica Maritime Act, 2000, as amended;

(b) The Dominica Maritime Regulations, 2002, as amended.

APPLICABILITY: All Dominica flagged vessels and associated companies.

PURPOSE:

The purpose of this Circular is to bring to the attention of all concerned the relevant international instruments to which the Commonwealth of Dominica is a Party with which all Dominica flagged ships and associated companies must remain in compliance.

BACKGROUND:

On 21 September 2000 all International Conventions for which Dominica is a party came into force for all vessels under the Dominica International Registry.

REQUIREMENTS:

All Dominica flagged ships must remain in compliance with the following international instruments to which the Commonwealth of Dominica is a Party:

1. Convention on the International Maritime Organization, 1984 (IMO Convention);

- 2. 1993 Amendments to the IMO Convention which were adopted by the Assembly of the Organization on 4 November 1993 by Resolution A.735(18);
- 3. Protocol of 1992 to amend the International Convention on Civil Liability for Oil Pollution Damage, 1969;
- 4. International Regulations for Prevention Collisions at Sea, 1960;
- 5. Convention on Facilitations of International Maritime Traffic, 1965;
- 6. Protocol of 1992 to amend the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1971;
- 7. International Convention on Load Lines, 1966;
- 8. Protocol of 1988 Relating to the International Convention on Load Lines, 1966;
- 9. Convention on Limitation of Liability for Maritime Claims, 1976;
- 10. Protocol of 1978 Relating to the International Convention for the Prevention of Pollution from Ships, 1973; including:
