- SUBJECT: List of Suspended Vessels and Request for Cooperation Regarding Registration of these Vessels Elsewhere
- **REFERENCES:** (a) Commonwealth of Dominica International Maritime Act, 2000, as amended from time to time;

(b) Dominica Maritime Regulations (2002); and

(c) Convention on the Law of the Sea, Dec. 10, 1982, 1833 U.N.T.S. 397.

APPLICABILITY: This Circular applies to all Dominica flagged vessels, particularly those already categorized as suspended.

#### **PURPOSE:**

The Administration is providing this Circular to list the vessels categorized as suspended within the Administration's vessel registry, and to assert that although the following list of vessels were suspended by the Administration, they nevertheless remain registered under the flag of the Commonwealth of Dominica and thus remain subject to the Administration's flag state authority and jurisdiction. As such, Administration-suspended vessels are not eligible for provisional or permanent registration elsewhere unless and until they have satisfied all cancellation requirements with the Administration.

### **REQUIREMENTS:**

### 1. List of Suspended Vessels.

- 1.1 The following list of vessels are considered as suspended vessels within the Administration's registry in accordance with, *inter alia*, the International Maritime Act § 12 and the Dominica Maritime Regulations §§ 18(2); 18(4).
- 1.2 These suspended vessels are NOT de-flagged or deleted from the vessel registry of the Administration, and they remain registered with the Administration. Thus, all suspended vessels remain under the flag state authority and jurisdiction of this Administration unless and until they complete the appropriate vessel deletion requirements.

### 2. Vessel Deletion Requirements

- 2.1 CDP-200 provides for the registration of vessels to fly the flag of the Commonwealth of Dominica.
- 2.2 CDP-200 also lists the requirements for deletion of a vessel. All vessels registered to fly a nation's flag must apply for, and receive, a Certificate of Deletion from the flag state administration prior to applying for registration with another flag state.
- 2.3 The requirements for deletion can be found in CDP-200 at Section 6.3: "Certificate of Cancellation of Registry."
- 2.4 As per that Section, the following requirements must be met before the Commonwealth of Dominica will issue a Certificate of Deletion/Certificate of Cancellation of Registry:
  - 2.4.1 Certificate of Permission to Transfer (if applicable);
  - 2.4.2 Satisfaction of all recorded mortgages;
  - 2.4.3 Payment in full of all outstanding fees, penalties, and/or charges "of whatever nature due against the vessel or her owner[s]..." *This includes, but is in no way limited to, any Foreign Maritime Entity or International Business Company fees for entities related to the vessel, violation penalties, IMO and/or marine casualty fees, marine pollution fees, late payment penalties, etc.*; and
  - 2.4.4 Surrender of the original vessel documents to DMRI.
- 2.5 Owners of a suspended vessel seeking to cancel its registration and re-flag elsewhere will not be provided with a Certificate of Deletion until all requirements detailed in this Section 2 have been met. Any Certificate of Deletion a suspended vessel provides to another flag state authority or registry of ships is to be considered FRAUDULENT.

#### **REQUESTED ACTION BY OTHER FLAG STATE AUTHORITIES**

#### 3. Flag State Cooperation Requested

- 3.1 The Administration requests the cooperation of other flag state authorities globally in order to prevent any re-flagging of the above vessels, which have not received a Certificate of Deletion from this Administration and will not receive said deletion certificate until the vessel's owner(s) satisfactorily completes all requirements for deletion as listed under Section 2 of this Circular.
- 3.2 If a vessel on this list requests registration with another flag state authority's registry of ships, the Administration asks that the subject registry/authority reach out directly to the Administration at the below email address for assistance or more information.
- 3.3 Verification requests by other flag state authorities for Certificates of Deletion allegedly issued by the Commonwealth of Dominica may be sent to the Administration by email at the email address below, and a reply will be sent within 24 working hours.
- 3.4 The Administration requests that flag state authorities decline provisional and/or permanent registration for vessels that are categorized as suspended by the Administration, in accordance with Articles 91-92 of UNCLOS.<sup>1</sup>

<sup>1</sup> "Article 91 Nationality of ships

2. Every State shall issue to ships to which it has granted the right to fly its flag documents to that effect.

Article 92 Status of ships

1. Ships shall sail under the flag of one State only and, save in exceptional cases expressly provided for in international treaties or in this Convention, shall be subject to its exclusive jurisdiction on the high seas. A ship may not change its flag during a voyage or while in a port of call, save in the case of a real transfer of ownership or change of registry.

2. A ship which sails under the flags of two or more States, using them according to convenience, may not claim any of the nationalities in question with respect to any other State, and may be assimilated to a ship without nationality." Convention on the Law of the Sea, art. 91-92, Dec. 10, 1982, 1833 U.N.T.S. 397.

<sup>1.</sup> Every State shall fix the conditions for the grant of its nationality to ships, for the registration of ships in its territory, and for the right to fly its flag. Ships have the nationality of the State whose flag they are entitled to fly. There must exist a genuine link between the State and the ship.

#### **BY OWNERS/OPERATORS:**

#### 4. Requirements for Applicable Dominica-Flagged Vessels

4.1 Dominica-flagged shipowners may be removed from this suspended status upon working with the Administration to return to full compliance with Dominica and international law, as well as to satisfy any outstanding penalties/fines, if applicable.

# 4.2 The Commonwealth of Dominica will NOT issue a Certificate of Deletion to any vessel unless and until all of the requirements for cancellation/deletion have been satisfied.

4.3 Please plan to evidence satisfaction of these if requested upon application for deletion.
